## ITEMS FOR DISCUSSION

- 1. One (1) Fair Market Price Determination (FMPD) for PACE Enterprises of West Virginia, Inc. to collect and recycle office paper. Item voted on and approved by Committee (1 form).
- 2. One (1) Fair Market Price Modification (FMPM) for Bright Horizons for various soap, sanitizer, and wipe items. Kim Nuckles stated she had requested Aaron Jones of the Central Nonprofit Agency (WVARF) to consolidate these items into one form. Item voted on and approved by Committee (1 form).

## OLD BUSINESS

Committee member Doug Auten asked Aaron Jones of the Central Nonprofit Agency (WVARF) questions related to the eight (8) contracts surrendered by Goodwill Industries, Inc. Mr. Jones gave an update. Gary Wolfe of the Central Nonprofit Agency (WVARF) stated that state agencies do not have a problem paying the increased janitorial rates that are effective February 1, 2018.

## **NEW BUSINESS**

Discussion related to a new Community Rehabilitation Program (CRP) for the West Virginia Consolidated Public Retirement Board.

Aaron Jones of the Central Nonprofit Agency (WVARF) requested guidance for when a state agency no longer wants the services of a currently-utilized Community Rehabilitation Program (CRP).

Mr. Jones received email correspondence from Jim Hawley at the West Virginia General Services Division related to reducing janitorial labor hours at the Capitol (Building 1) by 110 hours as a result of upcoming renovative work. Discussion followed related to the impact on employees.
